

BOARD RESOLUTION NO. 17-10-42

Revised Guidelines on the Grant of EC Death Benefits to Surviving Wives and Children Beneficiaries of Muslims, Amending for this Purpose BR No. 14-07-34

WHEREAS, on July 28, 2014, the Commission issued Board Resolution No. 14-07-34 on "Guidelines on the Grant of EC Death Benefits to Surviving Wives and Children Beneficiaries of Muslims" dated July 28, 2014";

WHEREAS, under the said Resolution, upon the work-connected death of a covered Muslim husband, the total amount of EC death monthly pension shall be divided equally among the wives-beneficiaries up to a maximum of four, if any. Further, in case of death or re-marriage among the wives, the pension shall be equally redistributed to the remaining wives-beneficiaries, if any.

WHEREAS, a review of the implementation of the Board Resolution was made in consultation with the UP-Institute of Islamic Studies (UP-IIS) in relation to Muslim culture, customs and traditions:

WHEREAS, the UP-IIS has provided the following pertinent Rules on Islamic Succession for consideration:

- 1. Wives of Muslim husband do not enjoy hereditary rights from each other;
- 2. The children enjoy successional rights from the father and from their respective maternal origins only;

WHEREAS, the following rules have been recommended by the UP-IIS:

1. That upon the work-connected death of a covered Muslim husband, the total amount of EC death benefits (monthly pension) shall be divided equally among the wives of the Muslim husband; an amount equivalent to ten percent (10%) of the MIB shall be granted for each dependent child, not exceeding five, beginning with the youngest and without substitution;

- 2. Upon the death of any of the wives of the Muslim husband, the share of the deceased shall not be redistributed among the remaining wives;
- 3. Upon the emancipation or death of any of the dependent children, the share of the said child(ren) shall not be redistributed equally among the primary beneficiaries.

WHEREAS, Article 183 [177] (c) of P.D. No. 626, as amended, empowers this Commission "to approve rules and regulations governing the processing of claims;"

NOW THEREFORE, ON MOTION DULY MADE AND SECONDED

This Commission **RESOLVES** as it hereby **RESOLVED** to prescribe the following revised guidelines on the grant of EC death benefits to the qualified wives and children beneficiaries of Muslim husband:

- 1. In the event of the death of a Muslim husband, the monthly income benefit (MIB) shall be equally divided among the wives of the Muslim husband. An amount equivalent to ten percent (10%) of the MIB shall be granted to each dependent child, not exceeding five, beginning with the youngest and without substitution;
- 2. The five qualified dependent children shall be counted from among the collective number of children of the Muslim husband;
- 3. Upon the death or re-marriage of any of the wife-beneficiary, her monthly EC pension shall not be divided equally and re-distributed among the remaining wives and unemancipated children;
- Upon the death of the unemancipated child, the child's share shall not be divided equally and re-distributed to all wives and unemancipated siblings.

RESOLVED FURTHER that all previous Rules or Resolutions inconsistent with this Resolution are hereby repealed or modified accordingly;

RESOLVED FINALLY, that this Resolution shall take effect 15 days after its publication in a newspaper of general circulation and copy of this Resolution be furnished to the GSIS and to the SSS for guidance and compliance.
