All interested bidders are required to settle the prescribed fee for the said documents not later than the deadline of submission of bids.
- 5. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.1.
- 6. Submission of bids and/or modification of bids beyond the deadline shall not be accommodated as provided under the Revised Implementing Rules and Regulations (RIIR) of R.A. No. 9184.
- 7. Subject to the pertinent provisions of R.A. No. 9184 and its RIIR, the Employees' Compensation Commission (ECC) reserves the right to reject any bid or to annul the bidding process at any time prior to the awarding without thereby incurring any liability to the bidders.
