Eight Asian countries, including the Philippines, signed the declaration for the development of partnership among the member organizations of the Asian Workers' Compensation Forum on 25 October 2012 in Seoul, South Korea for the development of workers' compensation and the enhancement of social security in Asian countries.

Representatives of workers' compensation organizations in Asia, including the Emplayees' Compensation Commission of the Philippines, National Social Security Fund of Cambodia, PT Jamsostek of Indonesia, Ministry of Labor and Social Welfare of Lao PDR, Social Security Organization of Lao PDR, Social Security Organization of Malaysia, Social Insurance General Office of Mongolia, Korea Workers' Compensation & Welfare Service of the Republic of Korea, Department of Labour of Sri Lanka, Office of the Commissioner for Workmen's Compensation of Sri Lanka, Social Security Office of Thailand, Vietnam Social Security, gathered on this momentous occasion and participated on its inaugural General Assembly. Success under the **KaGabay Program**

Aldrin Ojastro, a seaman who met an accident while on board an ocean-going vessel recently received benefits under the ECC KaGabay Program. The program provides a special economic assistance for occupationally-disabled worker (ODWs) who lost employment by reason of workrelated sickness or injury.

Ojastro worked as a pump-man at Stolt Nielsen Inc. for twelve years before he met an accident on board the vessel. The accident caused him severe back pain so he had to stop working. He was given an EC temporary total disability (TTD) benefit and

The 5th Asian Asbestos Initiative Conference

Four representatives from the Philippines, including a medical doctor from the Employees' Compensation Commission (ECC), participated in the 5th Asian Asbestos Initiative (AAI) Conference in Busan, South Korea on November 6-8, 2012 to develop academic platform on which researches and administrators from different countries can share relevant core technologist relative to Asbestos.

The conference theme was Applying Science to Practice. It was chosen to enhance mutual understanding and technical support for preventing asbestos problems among Asian countries and government sectors and mode of actions for prevention, treatment and compensation of Asbestos-related Diseases (ARDs). It was hosted and organized by the Ministry of Environment, Republic of Korea and supported by the University of Occupational and Environmental Health, Japan. There were 112 participants from 16 countries including Australia, Bangladesh, Bhutan, Cambodia, India, Indonesia, Japan, South Korea, Lao PDR, Malaysia, Mongolia, Palau, Philippines, Thailand, Uk and Vietnam.

The four members of the Philippine delegation were from the University of the Philippines, the Lung Center of the Philippines, the Occupational Safety and Health Center, and Dr.Sarah Antonia I. Concepcion of the Employees Compensation Commission.

Dr.Concepcion presented the development of Asbestos-related

Disease as a compensable disease under the Employees' Compensation Program, otherwise known as Presidential Decree No. 626, as amended.

Association (ASSA), European Workers' Compensation Forum (EWCF), International Association of Industrial Accident Boards and Commissions (IAIABC), and Rehabilitation International (RI); cooperate on the development of the workers' compensation in the countries of the member organizations.
