# ECC taps 16 hospitals to help occupationally-disabled workers

The Employees' Compensation Commission recently forged commitments with 16 various hospitals for a more effective Quick Response Program. With the closer coordination with hospitals, assistance to workers who sustained injuries, contracted sickness or died while performing their duties can now be provided immediately.

Based on the commitments of hospitals, they will provide the ECC with immediate information on emergency admissions and out-patient cases involving workers who sustained injuries or contracted sickness while working.

In turn, the ECC will right away conduct visits to the patients in the hospitals. In this way, the ECC can provide psychosocial counselling, if needed, and facilitate the provision of information to claim EC benefits.

## ECC helps fisherman regain employment

It was one fine day for a group of fishermen while they were on board a ferry in Palawan. However, the cable of the ferry was stuck in a rock during the sail. Romeo Palay had no choice but to cut the cable otherwise, the vessel will capsize due to strong current. Unfortunately, Palay's hand was hit by a purse line cable which resulted to the amputation of his right hand.

Palay's cousin informed him that he can avail benefits from the Employees' Compensation Program because the incident was work-related. At first, Palay did not believe his cousin but when he found out that his cousin received an artificial finger when it had a work-related accident, he immediately filed EC claims at the Social Security System.

Palay was able to receive from the Employees' Compensation Commission a permanent partial disability pension of P4,186 monthly for 39 months.

In addition, Palay also received from the EC Program free eight sessions of occupational therapy worth P3,200 at the Philippine General Hospital. He was also given by the ECC an artifi-

# Machine operator bounces back from setback through the help of the ECC

January 29, 2014 was an ordinary working day for Bryan Anthony Cortes. He went to work and started operating the mixing roll machine in a manufacturing company. However, the ordinary day turned into a nightmare for Cortes when his right thumb was caught by the chain of the machine which caused its amputation.

Since it was a work-related incident, Cortes was able to receive rehabilitation services from ECC which consist of eight physical therapy sessions worth P3,200 and a high definition silicone finger worth P30,000.

Right after he got his free artificial finger from the Employees' Compensation Commission, his days returned to regular working days once again. Cortes was able to get his old job back as a machine operator.

"The ECC, as a government agency that provides meaningful and appropriate compensation to workers in the event of work-related contingencies, would like to reach out to all the occupationally-disabled workers to help them improve their lives after the work-related incident," ECC Executive Director Stella Zipagan-Banawis

shared.

Banawis added that ECC understands that it is very hard for workers who were injured from work to recover from a particular unfortunate event in their lives. Hence, the ECC continues to initiate programs for the ODWs to help them improve the quality of their lives.

Palay also shared that he never thought that the ECC will actually give him an artificial hand. The prosthesis is very useful for him. He is so grateful that there is a government agency willing to help occupationally-disabled workers like him.

Palay is now back in the fishing company and works as a generator operator.
