The "**Green Our DOLE Program (GODP) Action Committee**" shall have the following functions:

1. Prepares the GODP action plan, monitor its compliance and action report quarterly to the Administrative Service;
2. Oversees the maintenance of cleanliness and orderliness in the workplace;
3. Supervises the implementation of energy conservation on water and electricity consumption;
4. Adopts and implements other greening initiatives set forth under DOLE A.O. 509, s. 2011;
5. Meet regularly at least once a month to identify and resolve issues and concerns on the implementation of GODP action plan.

Further, in compliance with the abovementioned directives, **Dr. DIANE KRISSELLE L. QUINLOG** is hereby designated as Occupational Health Officer and **DR. RAYMOND C. BANAGA** as Occupational Safety Officer for the ECC. **MR. KENO S. FLORES** shall assist **Dr. Banaga** in his duties as Occupational Safety Officer.

Finally, the designation of **Atty. JONATHAN T. VILLASOTO**, Deputy Executive Director and **Ms. MARIBEL S. T. OLIVEROS**, Chief, Administrative Division, as Permanent and Alternate Representatives, respectively, to the DOLE GOPD Audit Committee under Office Order no. 12-129 remains in effect.
