PB-ECC-2023-10 Public Bidding for the Repair/Renovation of the 3rd Floor of the ECC Building

In accordance with Section 22.5 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 and in response to queries and clarifications raised by prospective external providers, the ECC- Bids and Awards Committee issues this Bid Bulletin on the subject procurement:

Engineering Design and Specification Query – Requesting the Material Specifications	Design and Specifications of the Engineering Works may vary depending on the proposal of each bidder.		
and Design for Engineering Works (e.g. Mechanical, Electrical, Electronic, Plumbing and Sanitary, and Fire Protection) be provided by the procuring entity (ECC) so that all bidders will follow same layout and specifications.	As stated in <i>Section VI. B Scope of Works</i> of Bid Document, MEPF Consultancy and Design is to be provided by the winning bidder hence it will not be provided by the procuring entity (ECC).		
PCAB Category Query – If the Philippine Contractors Accreditation Board (PCAB) license and registration minimum requirement of Medium A Category B stated in <i>Section III.20</i> of Bid Document be lowered to Small B Category C&D with single largest project amounting to not less than 15M up to 30M, considering that the Approved Budget for the Contract is amounting to 17.9M.	The ECC – BAC retains the minimum requirement for a PCAB License and registration of Medium A Category B as stated in Section III.20 of the Bidding Document.

<u>COVID Protocol Query</u> – If the procuring entity (ECC) shall have preventive and control measures for Covid-19 like the requirement of Covid-19 Vaccination	With the lifting of the State of Public Health Emergency pursuant to Presidential Proclamation No. 297 dated 21 July 2023, the ECC shall implement the following preventive and control measures for COVID-19:

Cards, or strict implementation of wearing masks at all times?	 All personnel of the contractor shall submit a photocopy of their COVID-19 vaccination cards prior commencement of works; Wearing of facemask is <u>encouraged</u> but not mandatory
Personnel Uniform Query – ls uniform required for construction workers?	No. Uniform is not required for the construction workers. However, they are encouraged to wear comfortable clothes and <u>required to use safety gears/</u> <u>clothing / equipment in accordance with OSHC rules</u> <u>and regulations.</u>
Site Inspection Certification Query – If the procuring entity (ECC) shall require a Site Inspection Certification?	No. Site Inspection Certification is not required
<u>Tools & Equipment Query</u> – If the procuring entity (ECC) shall require Proof of Ownership or Certification for small tools and equipment like power tools and ladders?	No. The contractor need not provide a proof of ownership / certification for small tools/ equipment. It shall only furnish the ECC with the list of equipment and tools that it will utilize during the renovation.
(In practice, Proof of Ownership/Certification is only required for heavy equipment and machines)	
<u>Ocular Visit Query</u> – When can the bidder schedule for ocular visit at ECC Third Floor?	Ocular visit may be conducted from November 13 to 22, 2023, Mondays to Fridays, from 8:00 a.m. to 2:00 p.m. Prospective bidders who wish to inspect the renovation site may email their request to supply@ecc.gov.ph and/or chua ac@ecc.gov.ph. They shall include in their email, their preferred date and time of inspection and the names and positions of their personnel authorized to conduct the ocular. The aforesaid personnel shall present their valid IDs to the ECC Security on the day of their visit.

All other portions of the subject Philippine Bidding Documents (PBDs) affected by the abovementioned amendments shall be made to conform to the same. All other matters which are not included in this Supplemental Bid are hereby maintained by the ECC-BAC.
