In accordance with Section 51.5 of the Implementing Rules and Regulations of Republic Act No. 12009 and in response to queries raised by prospective bidders during the Pre-Bid Conference, the ECC- Bids and Awards Committee (BAC) issues this Bid Bulletin on the subject procurement:

Queries	BAC Response
Will an expired PCAB license, accompanied by the Official Receipt for renewal payment, be considered compliant with the eligibility requirements?	An expired Philippine Contractors Accreditation Board (PCAB) license, even when accompanied by an Official Receipt (OR) for renewal payment, does not meet the eligibility requirements for public procurement. Section 23.1(a)(vi) of the Implementing Rules and Regulations (IRR) of RA 12009 requires that contractors submit a valid PCAB license as part of the eligibility requirements for infrastructure projects. A valid PCAB license must be current and not expired at the time of bid submission. Additionally, the Government Procurement Policy Board (GPPB) has issued Resolution No. 10-2019, which explicitly states that a Temporary PCAB License is not acceptable as an eligibility requirement in lieu of a valid PCAB license for government bidding. This resolution underscores the necessity for contractors to ensure that their PCAB licenses are valid at the time of bid submission to be considered eligible for procurement activities
